ProAmpac Collaboration & Innovation Center to consist of 24,000sq. ft new and about 10,000sf. ft existing space to be renovated.

Unique International space for Customers to collaborate and innovate new packaging from idea, to testing and ultimately end user market.

Two other ProAmpac sites were closely reviewed: Cincinnati, OH and Neenah, WI were considered for housing the CIC, but Rochester was chosen based on a number of factors including costs, availability and level of state and county investment incentives, availability of packaging technical talent (Rochester Inst. of Technology-RIT) and sites existing quality and safety performance.

Expand the Rochester, NY (formerly PacTech) owned facility to include a customer collaboration and product innovation facility. This CIC and expansion in Rochester, NY aligns ProAmpac's strategic vision to have one centralized facility to house; analytical testing, addition of filling equipment for product application performance testing and house the Design and Sample Lab (DASL) for pouch prototyping. The site will accelerate ProAmpac growth by shortening lead times on product "ideation to launch," while adding filling & in-house performance testing capabilities. Today, ProAmpac relies primarily on our customers to understand how our products will perform often resulting in delays due to necessary product redesigns following filling or performance trial failures. Consolidating in-house testing will improve first time trial approvals while positioning ProAmpac better against our competition.

The CIC aligns with the strategic acquisition vision we as an organization had for Rochester. New hires to staff the testing and development labs have been phased in-line with the growth assumptions The existing HR, finance, supply chain, facilities maintenance and site management will have responsibility for the incremental hires. A key driver behind the PacTech purchase in 2018 was the team's ability to demonstrate an innovative approach to short-run packaging design in a world-class, safe and clean operating environment.

In addition to the construction and renovations ProAmpac will also be investing \$1,200,000.00 in manufacturing equipment.
