Generations Child Care, Inc. (Generations) operates six child care centers in the Rochester area offering infant and toddler care, preschool, wraparound before and after school programs, NYS Dept. of Education funded free Universal Pre-K as well as elder care day programs. Three of the centers are located in the City of Rochester. Generations is proposing the purchase of a bus for transportation of children within Monroe County, including to and from programs, where families do not have transportation. The \$54,776 project will impact 125 FTEs and is projected to create 2 new FTEs over the next three years. Generations has been approved for a GreatRebate on the equipment purchase through the Monroe County Industrial Development Corporation and is seeking approval of the EquiPlus sales tax exemption.
