10 WINTHROP STREET, LLC, a New York limited liability company for itself, or a related entity formed or to be formed (collectively, the "Company") has requested that the Agency assist with a certain Project (the "Project"), consisting of: (A) the retention of a leasehold interest in an approximately 1.56-acre parcel of land located at 10 Winthrop Street in the City of Rochester, New York 14607 (the "Land") together with the existing approximately 42,440 square-foot building thereon (the "Existing Improvements"); (B) the renovation the first floor of the Existing Improvements (the "Improvements"); and (C) the acquisition and installation therein, thereon or thereabout of certain machinery, equipment and related personal property (the "Equipment" and, together with the Land, the Improvements, the "Facility"), all for lease to the Company and sublease to RDG + Partners CPAs, PLLC (the "Tenant") for use in its business as an accounting firm.

The Agency will retain a leasehold interest in the Facility and lease the Facility back to the Company. The Company and/or Tenant will operate the Facility during the term of the lease. At the end of the lease term the Agency's leasehold interest will be terminated. The Agency contemplates that it will provide financial assistance (the "Financial Assistance") to the Company in the form of sales and use tax exemptions and, if necessary, a mortgage recording tax exemption, consistent with the policies of the Agency, and a partial real property tax abatement.





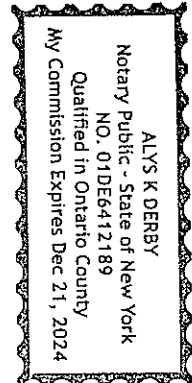
