

ANNUAL COMIDA REPORTING

January 14, 2013

- 1. This report covers our site visits between January 1, 2012 and December 31, 2012.
- 2. During this period Loewke Brill made 864 site visits.
- 3. During this period Loewke Brill made "31" Follow up visits.
- 4. Loewke Brill checked for residence with 6,351 workers.
- 5. Of those workers, there was "9" non-compliant.
- 6. As of December 31, 2012 all monitored sites were in compliance at time of our inspection.
- 7. There was a 99% average compliance on the initial site visit.
- 8. All sites were 100% compliant within 24 hours of the initial visit.
