

SUPPLEMENTAL NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that a public hearing pursuant to Article 18-A of the New York State General Municipal Law will be held by the County of Monroe Industrial Development Agency (the "Agency") on Thursday, the 13th day of May, 2021 at 10:00 a.m., local time, at the Agency's offices, 50 West Main Street, Rochester, New York 14614. **PLEASE NOTE** the special hearing logistics and instructions included at the end of this notice.

AMAZON.COM SERVICES LLC, a Delaware limited liability company (the "Company"), previously submitted an application to the Agency, a copy of which can be found at <https://monroecountybusiness.org/wp-content/uploads/USRE-app-for-web.pdf>, requesting that the Agency assist with a certain project, more particularly described in the original Notice of Public Hearing, a copy of which can be found at <https://monroecountybusiness.org/wp-content/uploads/USRE-Public-Notices.pdf>. This hearing supplements the hearing held by the Agency on January 15, 2021. Subsequently, the Company has submitted a project modification application to the Agency requesting that the Agency increase the Financial Assistance (as hereinafter defined) to assist with a certain Project (the "Project"), consisting of the acquisition and installation of certain material handling equipment, machinery and related personal property (collectively, the "Equipment") in, on or about the newly constructed approximately 2,600,000 square-foot warehouse/distribution center located at 2600 Manitou Road in the Town of Gates, New York 14624. The Agency contemplates that it will provide financial assistance to the Company in the form of sales and use tax exemptions (the "Financial Assistance").

PLEASE NOTE SPECIAL PUBLIC HEARING CONDUCT INSTRUCTIONS AND INFORMATION:

In accordance with Section 859-a of the Act, a representative of the Agency will be at the above-stated time and place to present a copy of the Company's project Application (including a cost-benefit analysis), which is also available for viewing on the Agency's website at: <https://monroecountybusiness.org/comida/projects/>. However, given the ongoing COVID-19 public health crisis and related Executive Orders issued by Governor Andrew M. Cuomo, the Agency will not accommodate in-person public attendance or participation at this hearing. Nonetheless, and in furtherance of the provisions of Section 859-a of the Act requiring interested parties be provided a reasonable opportunity, both orally and in writing, to present their views with respect to the Project, the Agency will livestream the Public Hearing on its YouTube channel, https://www.youtube.com/channel/UCfd3PpBrm5ZRh5z2_lqeJ5Q/featured, with written comments accepted on that platform in real time.
