## **NOTICE OF PUBLIC HEARING**

NOTICE IS HEREBY GIVEN that a public hearing pursuant to Article 18-A of the New York State General Municipal Law will be held by the County of Monroe Industrial Development Agency (the "Agency") on Friday, the 15th day of January, 2021 at 11:00 a.m., local time, at the Agency's offices, 50 West Main Street, Rochester, New York 14614. **PLEASE NOTE** the special hearing logistics and instructions included at the end of this notice.

441 EAST LLC, a New York limited liability company for itself or a related entity formed or to be formed (collectively, the "Company") has requested that the Agency assist with a certain Project (the "Project"), consisting of: (A) the acquisition of a leasehold interest in an approximately 1.70-acre parcel of land located at 441 East Avenue in the City of Rochester, New York 14607 (the "Land") together with the existing approximately 21,658 square-foot building thereon (the "Existing Improvements"); (B) the renovation of the Existing Improvements into modern office space including, but not limited to, a new main entryway and updated building mechanical systems (collectively, the "Improvements"); and (C) the acquisition and installation therein, thereon or thereabout of certain machinery, equipment and related personal property (the "Equipment" and, together with the Land and the Improvements, the "Facility"); all for use by Lawley, LLC (the "Tenant") in its insurance business.

The Agency will acquire a leasehold interest in the Facility and lease the Facility back to the Company. The Facility will be initially operated and/or managed by the Company. At the end of the lease term the Agency's leasehold interest will be terminated. The Agency contemplates that it will provide financial assistance (the "Financial Assistance") to the Company in the form of sales and use tax exemptions and, if necessary, a mortgage recording tax exemption, consistent with the policies of the Agency, and a partial real property tax abatement.
