SOUTH PARK DEVELOPMENT, LLC, a New York limited liability company for itself, or a related entity formed or to be formed (collectively, the "Company") has requested that the Agency assist with a certain Project (the "Project"), consisting of: (A) the acquisition of a leasehold interest in a portion of the vacant approximately 73±-acre parcel of land located at 1200 Lexington Avenue in the Town of Greece, New York (the "Land"); (B) the construction on the Land of a one-story approximately 180,000 square-foot building (collectively, the "Improvements"); and (C) the acquisition and installation therein, thereon or thereabout of certain machinery, equipment and related personal property (the "Equipment" and, together with the Land and the Improvements, the "Facility"); for use as a distribution facility. The Facility will be initially operated and/or managed by the Company.


