

NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that a public hearing pursuant to Article 18-A of the New York State General Municipal Law will be held by the County of Monroe Industrial Development Agency (the "Agency") on the 17th day of December, 2012 at 9:30 a.m., local time, in Community Room A at the Greece Town Hall, One Vince Tofany Boulevard, Rochester, New York 14612, in connection with the following matter:

AMBASSADOR HOMES INC., a New York corporation, its successors or designees (collectively, the "Company") has requested that the Agency assist with a certain Project (the "Project"), consisting of: (A) the acquisition of a leasehold or other interest in an approximately 5.53-acre parcel of vacant, wooded land located at 2594 English Road in the Town of Greece, Monroe County, New York (the "Land"); (B) the construction on the Land of a residential rental community comprised of six (6) buildings, each containing a "Side A" consisting of an approximately 1350 square-foot ranch-style unit and a "Side B" consisting of an approximately 1500 square-foot ranch-style unit with each unit including, but not limited to, 2 bedrooms, a great room, a covered rear deck, a 12-course basement and a 2-car garage (collectively, the "Improvements"), which Improvements will be occupied by seniors 55 years of age or older; (C) the acquisition and installation in and around the Improvements of certain items of machinery, equipment and other tangible personal property including (the "Equipment" and, collectively with the Land and the Improvements, the "Facility"). The Facility will be initially operated and/or managed by the Company.

The Agency will acquire an interest in the Facility and lease the Facility to the Company. The financial assistance contemplated by the Agency will consist generally of the exemption from taxation expected to be claimed by the Company as a result of the Agency taking an interest in, possession or control (by lease, license or otherwise) of the Facility, or of the Company acting as an agent of the Agency, consisting of: (i) exemption from state and local sales and use tax with respect to the qualifying personal property portion of the Facility, (ii) exemption from mortgage recording tax with respect to any qualifying mortgage on the Facility, and (iii) exemption from general real property taxation with respect to the Facility, which exemption shall be offset, in whole or in part, by contractual payments in lieu of taxes by the Company for the benefit of affected tax jurisdictions.

A copy of the Company's application, containing the Benefit/Incentive analysis, is available for inspection at the Agency's offices at 8100 CityPlace, 50 West Main Street, Rochester, New York 14614 during normal business hours, Monday through Friday, and will be available for inspection and review at the above-scheduled Public Hearing.

The Agency will at the above-stated time and place hear all persons with views in favor of or opposed to either the location or nature of the Facility, or the proposed financial assistance being contemplated by the Agency. In addition, at, or prior to, such hearing, interested parties may submit to the Agency written materials pertaining to such matters.
