

#### 2018 Overview

Overall our programs exceeded 2017. Cash incentive programs, the Greats, and training programs contributed over \$1 million in additional company investment. Job creation from these programs were up 15%. SBA 504 Loans lead the way in financing incentives programs. Up \$2 million in company investment and 36 jobs were created on these seven loans giving 2018 one of our top jobs to loans ratio.





2018 Loans results to date have outpaced 2017 results, despite active competition in the marketplace


# SBA 504 Portfolio Growth

# **BOCES SAME**

### Summer Advanced Manufacturing Experience (SAME)

- Established in 2011 at Monroe #2 Orleans BOCES and at Monroe #1 BOCES in 2016
- Established by Monroe County as an effort to expose incoming 9<sup>th</sup> and 10<sup>th</sup> graders to education and careers in advanced manufacturing
- 2018 had 24 graduates
- Each graduate receives three college credits at MCC in TAM 141 which goes towards a Precision Manufacturing Certificate
- Students also receive 90 hours of training on state of the art advanced manufacturing equipment
- Students also tour at least six manufacturing and optics companies in the Greater Rochester region







# **2018 Proposed Program Updates**

### Monroe Manufacturers Rewards Small Business Program

- Targets smaller manufacturers
- Allows for \$1000 rebate on manufacturing equipment purchases between \$10,000 and \$24,999
- No job creation required

#### Monroe Home Grown Market

- Targets food, beverage and agriculture produces
- Provides incentive for farmers of food production that have a retail outlet for furniture, fixture and equipment investments
- Not for farmers markets
- No job creation required
