The cost of materials has increased since the original budget was proposed and a couple of delays in getting approvals have created extra cost and financing requirements. Simultaneously, our aggressive hiring has put a strain on cash flow and hindered our ability to meet our obligations during this challenging time. Our hope is that we can buy some time as we incur further escalation in costs before we can realize the full benefit of additional staff and equipment capacity.

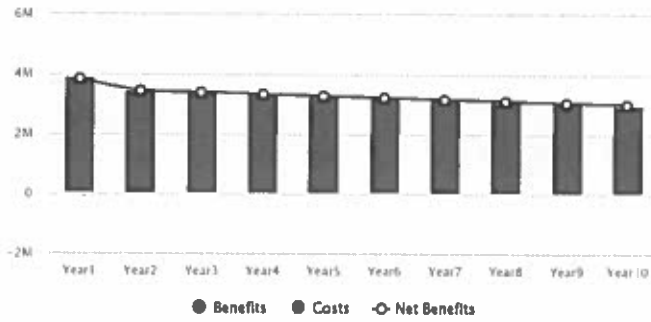

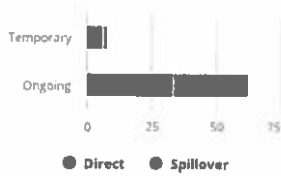
Discounted* Net Benefits for Forge Metal Finishing, Inc. by Year

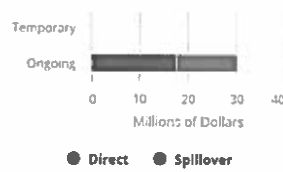
Total Jobs

Cost-Benefit Analysis

A cost-benefit analysis of this proposed investment was conducted using InformAnalytics, an economic impact model developed by CGR. The report estimates the impact that a potential project will have on the local economy based on information provided by COMIDA. The report calculates the costs and benefits for specified local taxing districts over the first 10 years, with future returns discounted at a 2% rate.
