Precision Optical Transceivers, Inc. will relocate to an existing building in the Town of Henrietta, Monroe County and purchase machinery and equipment focused on optical transceiver assembly and production. The approximate 43,000 square foot location will include engineering labs, production space, and office space. The project investment will exceed \$3 million and create 35 net new jobs over the next 3 years and retain 62 existing employees.

During the times at which we are currently facing, particularly a pandemic, it is a risky business decision to commit to relocating our operations to a new facility within NYS. While this commitment requires substantial investment and resources, this project is crucial to our continued growth. Over the past few years, we have out-grown our facility and need to have resources available to hire and maintain talent to contribute to the success of our operations. In addition, we are in the beginning stages of manufacturing a new product and our desire is to be able to have enough space and human resources to manufacture this product in-house, rather than outside of NYS. We need to preserve capital in order to make this significant future investment.

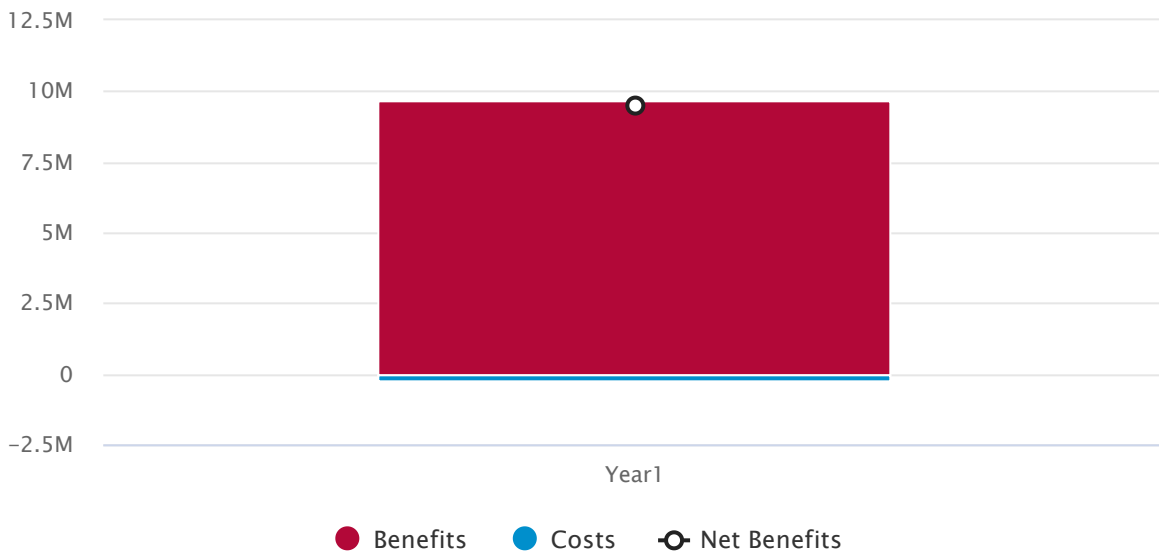

Discounted* Net Benefits for Precision Optical Transceivers, Inc. by Year

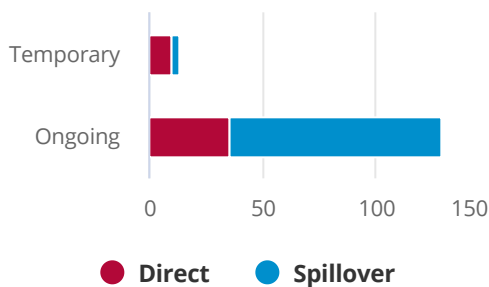

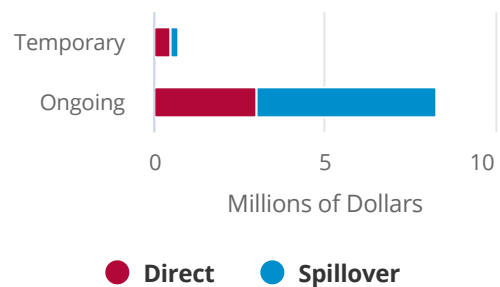

Cost-Benefit Analysis
