USRE MANITOU, LLC, a Delaware limited liability company for itself or a related entity formed or to be formed (collectively, the "Company") and Amazon.com Services LLC, a Delaware limited liability company (the "Tenant"), have submitted an application to the Agency requesting that the Agency assist with a certain Project (the "Project"), consisting of: (A) the acquisition of a leasehold interest in an approximately 100-acre parcel of land located at 2600 Manitou Road in the Town of Gates, New York 14624 (the "Land"); (B) the construction on the Land of an approximately 2,600,000 square-foot warehouse/distribution facility, related infrastructure (site work, utilities, roadway improvements and landscaping) and associated exterior improvements (parking and loading areas, sidewalks, lighting and signage) (collectively, the "Improvements"); and (C) the acquisition and installation therein, thereon or thereabout by the Company and the Tenant of certain material handling equipment, machinery, equipment and related personal property (the "Equipment" and, together with the Land and the Improvements, the "Facility"); all for sublease to the Tenant for use as a fulfillment center.

The Agency will acquire a leasehold interest in the Facility and lease the Facility back to the Company. The Facility will be initially operated and/or managed by the Company. At the end of the lease term the Agency's leasehold interest will be terminated. The Agency contemplates that it will provide financial assistance (the "Financial Assistance") to the Company and the Tenant in the form of sales and use tax exemptions and, if necessary, a mortgage recording tax exemption, consistent with the policies of the Agency, and a partial real property tax abatement.
